### General Requirements:

- 1) Full copies of itemized receipts & paid invoices must be attached showing make, model, quantity, and purchase date
  - 2) Heat pump water heater (HPWH) must be installed to manufacturer's specs.
  - 3) The HPWH(s) must replace an existing electric water heater.
  - 4) For new construction only split HPWH are eligible.
  - 5) Only one rebate may be claimed per home. Accessory dwelling unit with a separate plumbing system may qualify for a second rebate.
  - 6) Rebate Application must be submitted within one year of purchase date,
  - 7) Rebate shall not exceed the pre-tax purchase price.
  - 8) Access to HPWH shall be granted upon request by a PUD &/or BPA representative to verify installation.
  - 9) HPWH installations that receive an instant rebate from a Participating Installers are not eligible for this rebate.
- Program may be modified/discontinued at anytime. This form expires 9/30/2022.**
