- Small business or non-profit that has incurred a financial hardship due to the COVID-19 public health emergency, resulting in a significant reduction in revenue, business disruption, and/or increased operating costs.

CERTIFICATION OF FINANCIAL HARDSHIP (If you sign this form, all of these statements must be true)

I CERTIFY, UNDER PENALTY OF PERJURY, THE FOLLOWING:

- i. That the household income and household size indicated in the Application is accurate (applies to residential customers only);
- ii. Because of the loss of income, increase in expense or other financial hardship as indicated within the application, the household, business, or non-profit organization cannot pay the utilities without jeopardizing the Applicant's ability to pay for rent, food, medical and related expenses, health insurance premiums, childcare, job-related transportation expenses or other organization operating costs vital to its continued operations;
- iii. For residents not qualified as low to moderate income, businesses and non-profits, the non-payment of utilities due is caused by a financial impact from the COVID -19 public health emergency;
- iv. The household, business or non-profit organization has paid partial utilities, to the extent possible, considering the financial hardships incurred; and
- v. The information provided in the application is a true and accurate statement of the financial hardship the household, business or non-profit organization has experienced related to the COVID-19 public health emergency.

READ BEFORE SIGNING:
 This document is a formal application for utility debt relief through federal stimulus funding ("American Rescue Plan Act" or "ARPA") for the limited purposes identified in the Interagency Agreements between the U.S. Department of the Treasury, Clallam County, and Public Utility District No. 1 of Clallam County (PUD). If it is determined during the course of any subsequent audit by the PUD, Clallam County or the United States Government, that the utility customer was not entitled to any ARPA funds that they received either in error or by false attestation, the customer will promptly reimburse the PUD for such payments upon request or have the amount added to their utility account balance. I give consent to Clallam PUD to disclose to Clallam County all information gathered during the application process and details of award granted under this program. Grant limitations: one utility assistance grant will be awarded per household, business, or non-profit. Funding will be capped at the past due amounts since March 1, 2020 with a total cap of \$4,000 for residential and \$10,000 for commercial and non-profit. Any pending assistance from other sources will be deducted from the ARPA grant. The cannabis industry is not eligible for ARPA assistance.
