

PERFORMING A WATER MAIN EXTENSION WITHIN THE DISTRICT'S ESTABLISHED WATER SERVICE AREAS

PUD No. 1 of Clallam County (the District) requires that each premise must have frontage on a water main to obtain water service. If a premise does not have water main frontage, a water main extension must be constructed in accordance with the Manager's discretion.

Customer performed water main extensions are covered in Section 26 of the District's <u>Water</u> <u>Service Requirements</u>. General details are as follows:

- 1. Specifications for the water main extension will be provided by the District pursuant with the District's <u>General Specifications for Water Main Extensions</u>.
- 2. Expenses related to engineered design, construction and inspection are the responsibility of the customer.
- 3. Water main extensions may be performed by a qualified contractor of the customer's choosing. Construction inspection shall be performed by a representative of the District.
- 4. Once complete, the new water main and associated appurtenances are to be granted to the District via a Bill of Sale (District provided form)
- 5. A written warranty is required against defects in materials and workmanship for one year following project completion.
- 6. If the water main extension crosses private property, a notarized perpetual easement granting access to the District for the operation, maintenance and/or replacement of the water main will be required.

Steps for coordinating a water main extension construction project:

- 1. Customer notifies the District of their intent to construct a Water Main Extension
- 2. District submits to the customer:
 - a. Water Main Extension Construction Application package
 - b. Water Main Extension Document Transmittal Package
 - c. District water map with general specifications and project specific construction requirements for new water main
 - d. Water Project Deposits and Charges indicating all District deposits and charges for providing water service and construction inspection
- 3. Customer consults Clallam County Fire Marshall for specifications and requirements regarding fire protection (note: Clallam County may require engineered project plans for instances when fire protection is required).
- 4. Customer completes and submits Water Main Extension Construction Application package back to the District for review and approval.
- 5. Once project is approved, the District submits to the customer approval to proceed indicating project specific conditions and easement requirements.
- 6. Customer pays all pertinent Water Project Deposits and Charges (All deposits and charges are subject to change without further notice; please contact the District for possible updated costs prior to payment).

7. Customer provides one week notice for a proposed preconstruction meeting with the contractor and a District representative.

Additional information and requirements during watermain construction are as follows:

- 1. The customer shall be responsible for the construction and installation of the water main, water services and any required appurtenances subject to District specifications and inspections.
- 2. Contractors must be licensed, bonded, and insured to perform water main installations. Please contact the District Contract Coordinator with questions regarding contractor requirements, 360-565-3212.
- 3. A preconstruction meeting with the contractor and a District representative shall be scheduled with the District at least one week prior to beginning construction.
- 4. All county road permits and utility locates shall be obtained by the contractor prior to beginning work.
- 5. Submittal of successful pressure and bacteriological test results to the District.

Requirements after contractor installation is complete:

- 1. Bill of Sale granting ownership of the water main and associated appurtenances to the District.
- 2. Written warranty against defects in materials and workmanship for one year following project completion.

Water service shall not be made available by the District from the water main extension until all conditions of the District as stated above have been satisfied.

Additional information regarding deposits and construction expenses:

- 1. Upon completion of construction, the District will do an accounting of the actual vs. estimated deposit charges. Should the actual cost vary from the estimate in the amount greater than \$50, appropriate refund or request for additional payment will be issued to the customer.
- 2. The District has established a policy whereby the initial cost of a water main extension may be reduced by "sharing" requirements of subsequent users of the main. The portions applicable to sharing are materials and labor for the water main extension only.
- 3. Receipts from contractor-installed mains showing the actual cost of the water main extension are required in order to determine any future sharing. *If appropriate receipts are not received by the District within six (6) months of the completion of construction, any potential sharing will be eliminated.*
