WATER MAIN REIMBURSEMENT AGREEMENT

RECITALS:

WHEREAS, the County is replacing sewer lines by contract in County Right of Way in Sekiu, WA; and

WHEREAS, the County is the lead agency for the construction of this project; and

WHEREAS, the PUD has established and abandoned water mains in portions of the construction area which are at the end of their useful life and which must be removed and/or replaced; and

WHEREAS, the water mains are located in County Right of Way; and

WHEREAS, to facilitate coordination of the work to be accomplished, the PUD has requested that the water main removal and/or replacement be included in the County contract for the sewer line replacement; and

WHEREAS, it is to the mutual benefit of the parties to this agreement that the work be performed under the County's contract, providing cost savings to the PUD, and to allow the County to safely perform and complete its sewer replacement project;

NOW, THEREFORE, pursuant to Chapter 39.34 of the Revised Code of Washington and in consideration of the mutual promises contained herein, the parties agree as follows:

- This agreement does not establish any separate legal or administration entity
- 2. The period of performance shall commence on January 15, 2024 and be completed by December 31, 2024 unless terminated sooner as provided in this agreement or extended by amendment of this agreement.
- 3. The County, as the lead contracting agency, agrees to pay the contractor for costs associated with the removal and/or replacement of the existing water mains as requested by the PUD subject to reimbursement by the PUD as set forth in Item 5 below. The cost is estimated at \$170,047.29 including tax.

- 4. Each party shall absorb and pay for its own engineering, administrative, and inspection costs associated with this project.
- 5. The PUD agrees to reimburse the County for the costs associated with the removal and/or replacement of the existing water mains installed on County rights-of-way.
- The County shall keep accurate records of the actual costs associated with the removal and/or replacement of the existing water mains.
- 7. The County shall bill the PUD monthly and after completion of the water line work.
- 8. Upon completion of the project and after final payment has been made, the water main will be the property of the PUD, and the sewer will be the property of the County.
- The PUD's obligations in this agreement extend to reimbursement of the costs of the work described herein only. The PUD shall not assume any liability for the quality, adequacy, or performance of the work, and should claim be made against the PUD in any way arising from the work, the County shall fully indemnify and defend the PUD against such claim.
- This agreement will be administered jointly by the County and the PUD pursuant to RCW 39.34.030(4)
- 11. This agreement may be terminated by either party for any reason upon 30 calendar days' written notification to the other party.

WATER MAIN REIMBURSEMENT AGREEMENT

THIS AGREEMENT is entered into on this _______ day of _______, 2024 between CLALLAM COUNTY, a political subdivision of the State of Washington (hereinafter the County), and PUBLIC UTILITY DISTRICT NO. 1 OF CLALLAM COUNTY, a municipal corporation (hereinafter the PUD).

RECITALS:

WHEREAS, the County is replacing sewer lines by contract in County Right of Way in Sekiu, WA; and

WHEREAS, the County is the lead agency for the construction of this project; and

WHEREAS, the PUD has established and abandoned water mains in portions of the construction area which are at the end of their useful life and which must be removed and/or replaced; and

WHEREAS, the water mains are located in County Right of Way; and

WHEREAS, to facilitate coordination of the work to be accomplished, the PUD has requested that the water main removal and/or replacement be included in the County contract for the sewer line replacement; and

WHEREAS, it is to the mutual benefit of the parties to this agreement that the work be performed under the County's contract, providing cost savings to the PUD, and to allow the County to safely perform and complete its sewer replacement project;

NOW, THEREFORE, pursuant to Chapter 39.34 of the Revised Code of Washington and in consideration of the mutual promises contained herein, the parties agree as follows:

- This agreement does not establish any separate legal or administration entity
- 2. The period of performance shall commence on January 15, 2024 and be completed by December 31, 2024 unless terminated sooner as provided in this agreement or extended by amendment of this agreement.
- 3. The County, as the lead contracting agency, agrees to pay the contractor for costs associated with the removal and/or replacement of the existing water mains as requested by the PUD subject to reimbursement by the PUD as set forth in Item 5 below. The cost is estimated at \$170,047.29 including tax.

- 4. Each party shall absorb and pay for its own engineering, administrative, and inspection costs associated with this project.
- 5. The PUD agrees to reimburse the County for the costs associated with the removal and/or replacement of the existing water mains installed on County rights-of-way.
- The County shall keep accurate records of the actual costs associated with the removal and/or replacement of the existing water mains.
- 7. The County shall bill the PUD monthly and after completion of the water line work.
- 8. Upon completion of the project and after final payment has been made, the water main will be the property of the PUD, and the sewer will be the property of the County.
