

## INVITATION TO SUBMIT BID Bid Number 240803

Prequalified contractors are invited to submit a bid for Clallam County PUD No. 1, transmission pole replacement with distribution along Highway 101, west of Beaver, WA. A preliminary Project Plan and Schedule is requested to be submitted with the bid.

All bidders must be prequalified in accordance with Washington State Regulations (RCW 54.04.085) prior to receiving bid proposals. Sealed bids will be received by PUD No. 1 of Clallam County, at 104 Hooker Road, Sequim, WA, until 2:30 p.m. Pacific Time on Tuesday, June 4, 2024. Bids submitted by mail must be sent to the PUD No. 1 of Clallam County, Attn: Contracts Coordinator, 100 Hooker Road Sequim, WA 98382. Bids must be in a sealed bid envelope with the name and address of the Bidder and bid number on the sealed envelope and then placed inside the delivery envelope to be mailed. Proposals must be filled out in ink or typewritten. No alterations or interlineations will be permitted, unless made before submission, initialed, and dated. At 3:00 p.m. Pacific Time, Tuesday, June 4, 2024, a public bid opening will take place in the Boardroom at the District's main office at 104 Hooker Road, Sequim, WA.

There will be a voluntary Pre-Bid Conference for this project. The Pre-Bid Conference will be held on Tuesday, May 28, 2024, beginning at 9:00 a.m. in the Carlsborg Dungeness Conference Room located at the 110 Idea Place, Sequim, WA 98382.
